

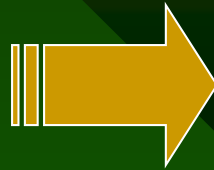
How to use the Direct Corporate Private Offering portal (DCPO) to conduct your due diligence

We provide the DCPO portal to help you learn more about our company

The DCPO portal contains 4 levels of authorized access to information

Level One contains generic public information about our Company.

Level Two contains information for Reg. D investors. If you like what you see on Level One, you can request authorization to proceed to Level Two.

Level Three is specific to commercial lenders

Level Four is the Investor Relations portal for those who have invested in the Company.

Level Three of the DCPO allows commercial finance and lending companies to access data.

- If commercial finance companies like what they see on Level One, they may request authorization to enter Level 3, where documents related to commercial loan applications are stored.

The DCPO helps us manage our investor communications

- We rely on your representations and statements regarding your credentials to make a private company investment.
- The software on our website monitors and records all communications between potential investors and the Company.

The DCPO process allows us to manage the terms and conditions of the Offering

1. We manage who has access to the documents held on each level of the due diligence process.
2. Our legal counsel controls the terms and conditions of the offering.
3. We provide enough information so that investors can “fend for themselves” in conducting their due diligence.

What we do on our side of the DCPO portal

- We have a fully functional administrative control panel to manage this web portal.
 - We upload the company documents
 - We approve investor access to the DCPO portal
 - We monitor all investor activity
 - We control which investors make an investment in our company.

What each investor does on their side of the DCPO portal

Step One: For Reg. D investors, you fill in your user registration document, and describe how you established your relationship with FloLogic and your qualifications to make an investment.

Step Two: We telephone you to conduct an interview to confirm your information.

Step Three: We authorize you to enter the DCPO portal, where you conduct your own due diligence. If you have questions, we archive your questions on Level Two, for all Level Two investors to preview.

You can download our subscription documents and fill them in.

- You can call us or email us with questions.
- We would be happy to meet with you.
- You can request a list of references to discuss market or technology.

Level Two contains the Offering Memorandum and Subscription Agreements

You can request authorization to enter Level Two, which contains:

- The Term Sheet
- The Private Placement Memorandum
- The Stock Holder Registration and Subscription Agreement
- Frequently Asked Questions about the Offering

Closing

- The completed Subscription Agreement is sent to the Company and the funds are placed in an escrow account established by our attorney, Hutchison Law Group, Raleigh, NC
- On the day of closing the funds are transferred to our corporate account and investor account to our company's account.
- Shortly thereafter you will receive a copy of signed Subscription Agreement and stock certificate

After the offering period, we have the option to open Level Four, the investor relations module

- Level Four Contains A Library of All Documents Related to the Offering.
- We use the Investor Relations module to keep investors informed about our Company's financial position.

After the offering period ends, commercial lenders can also request access to the investor relations module if they have made a loan to us.

- Our documents on Level 3 for commercial lenders and commercial finance companies are designed to make your job of investigating us easier.
- Our documents follow the industry standard documentation for your investigation.
- If you have your own unique application, we would be happy to fill that in off-line.
